

Compliance Associate Quality Assurance (Contract Position)

Description of the role:

The Quality Compliance Associate (QCA), ensures compliance with all relevant Health Canada, Canadian Food Inspection Agency & Corporate regulatory requirements. Using Good Manufacturing Practices (GMP) and Good Distribution Practices (GDP) is a critical success factor for commercial product supply to our customers. The QCA will contribute to the maintenance of the Quality Management System (QMS) by ensuring that all external (i.e. GMP, GDP) and internal BI requirements (i.e. Policies, SOPs, OCS, OCP & ACP) are followed. The QCA supports the Senior Quality Compliance Associate and the QA Manager.

Responsibilities:

The Compliance Associate will:

-Support and maintain document management system for local/regional SOPs/working instructions

-Support that applicable Corporate Procedures are transferred into local SOPs/Working instructions

-Participate in regular self-inspection programs to drive continues improvement and ensure local readiness for corporate or authorities inspections

-Support completion of CAPAs in a timely manner

-Perform GMP/GDP audits at suppliers and external partners

-Ensure product availability by reviewing 3PL documents including inbound product inspections, sampling finished goods, drug products and all packaging components and samples

-Provide support for technical product complaints and deviations.

-Ensure batch disposition (release/reject) for distribution if applicable as per local regulations

-Provide new product launch support

-Assess product quality through review of documentation and ensures that sales/marketing requirements are met

-Provide assistance by requesting certificates to ensure compliance with registration requirements -Provide assistance with Stability Program, Annual Product Quality Review.

-Maintain a) Master documents for all products, b) annual batch record program, c) Reference Chemical standard Program, d) coordinate sending samples with 3PL to external laboratory, e) retention samples program

-Ensure GMP/GDP & regulatory compliance of products/services which are outsourced to external parties. -Support the QA Senior Compliance Associate and QA Manager on audits, inspections, complaints, etc. as needed.
